Maha: One killed in tempo-dumper collision in Thane

Thane. A 47-year-old tempo driver has been killed in a collision between his vehicle and a dumper in Maharashtra's Thane district, police said on Tuesday. The accident took place at Savroli village on Monday evening when the victim was going to Vajreshwari from Ambadi village to get vegetables, a police official said. A speeding dumper collided head-on with the tempo, killing its driver, he said. A van and a car, which were behind the tempo, also suffered damages as they hit each other while trying to stop after the accident, the official said. The body was sent for a post-mortem, he said. The dumper driver was arrested and booked under provisions of the Indian Penal Code and the Motor Vehicles Act, he said.

13 new cases push Arunachal's COVID-19 tally to 16,282

Itanagar. Arunachal Pradesh's COVID-19 tally rose to 16,282 on Tuesday as 13 more people tested positive for the infection, a senior health official said. Forty-seven more people were cured of the disease, taking the recovery rate among the coronavirus patients in the state to 94.65 per cent, he said. The Capital Complex region reported the highest number of new cases at seven, followed by Tawang and Lepa Rada (two each) and Lower Dibang Valley and Tirap (one each), State Surveillance Officer Dr Lobsang Jampa said. Twelve infections were detected through rapid antigen tests and one during TrueNat tests, he said.

Arunachal Pradesh now has 817 active coronavirus cases, while 15,411 people have recovered from the disease and 54 patients have succumbed to the infection to date, he said. The state's positivity and fatality rates stand at 5.35 per cent and 0.33 per cent respectively, the official said.

The Capital Complex region, comprising Itanagar, Naharlagun, Nirjuli and Banderdewa areas, has the highest number of active cases at 586, followed by West Kameng (58), Lepa Rada (24) and Changlang (21), Jampa said. The state has so far tested 3,59,123 samples for COVID-19, including 829 on Monday, he added.

TRS MLA Nomula Narasimhaiah no more

Hyderabad. The ruling TRS MLA in Telangana Nomula Narasimhaiah died here on Tuesday owing to age related health issues. Narasimhaiah, MLA from Nagarjuna Sagar in Nalgonda district, was not keeping well and had lung-related problems, family sources said. The end came around 5.30 AM on Tuesday, they said. Narasimhaiah, a four-time MLA, was with the CPI (M) before joining the TRS in 2014. He was floor leader of CPI (M) in the Legislative Assembly in undivided Andhra Pradesh and was known for his articulation of people's issues.

Expressing shock over the sudden demise of Narasimhaiah, TRS president and Chief Minister K Chandrasekhar Rao said the departed MLA would be remembered as a leader who worked for people throughout his life. Narasimhaiah's death would be a loss to TRS and the people of his constituency, he was quoted as saying in an official release. Several state ministers and other TRS leaders, state Congress president and MP N Uttam Kumar Reddy, CPI leader K Narayana also condoled the death of Narasimhaiah.

Medical, paramedical colleges reopen in Karnataka

Bengaluru. All medical and paramedical colleges in Karnataka reopened on Tuesday, after being closed for nine months due to coronavirus outbreak and the subsequent lockdown. Dental, AYUSH, paramedical,



nursing and pharmacy colleges also resumed regular classes from today, by adhering to COVID-19 guidelines. Karnataka Minister for Health and Medical Education, Dr K Sudhakar had ordered the opening of the medical colleges from December 1. Already degree, diploma and engineering colleges started functioning from November 17 on a regular basis. According to sources in the Directorate of medical education, all necessary precautions have been taken in the medical colleges such as usage of face masks, hand sanitisers, and maintaining social distance. The faculties, staff and the students have been asked to produce a negative RT-PCR test report to attend the classes.

Why are farmers giving Burari 'open jail' in Delhi a thumbs down

New Delhi Empty spaces, tractors are strewn around and farmers huddled in small groups is what one sees at the massive 20-acre Burari ground. Despite elaborate arrangements by the Delhi government, including food, water, shelter and medical facilities, Nirankari ground in Burari finds few takers.

Farmer organisations have outright rejected the Centre's offer for they fear that if camped in Burari, their agitation could end up in a 'Jamia' or 'Shaheen Bagh' kind of protest where their patience is put to test.

Want to protest at Jantar Mantar

Burari might just be around 20 kilometres away from the Singhu border but farmers feel its miles away from the power centre of the country and any protest at the site will put them away from the glare.

Right at the entrance of the Burari ground is a camp set up by farmers from Amritsar. They sound the warning bell for fellow farmers. "We have been held captive here, this is an open jail, we wanted to go to Jantar Mantar but the police just dumped us here and now we can't leave. They say you can go back home but not to Jantar Mantar, so we won't budge," says Baljeet Singh. There is heavy police deployment at the Burari ground along with the presence of paramilitary



forces. However, it's the exit point that has the maximum attention of security personnel. Anyone leaving the premises is questioned and details are taken down.

Not allowed to leave, allege farmers

At Burari ground, some farmers have sat on a hunger strike in protest. Some burnt an effigy of Prime Minister Narendra Modi. "We are not being allowed to leave. We were picked up from Majnu ka Teela and kept at

Harinagar stadium. Since November 27, we have been holed up here. They want our protest to wither away at the Burari ground but we will not relent. We have enough stock and people are coming to help us. We demand the government to take back the black law," said Jaskaran Singh Kehenwal leader of farmers union from Amritsar. He insists that Jantar Mantar means sitting right under the nose of the government and

believes that it put farmers in the spotlight. Farmers threaten to block Delhi border

Farmers understand the geographical advantage of protest first the highway, then the Singhu border followed by the national highway. A critical lifeline, border points serve as lifelines to the National Capital Region. And it seems this is why farmers have declared to intensify their agitation by choking the five important nerve points that link Delhi to other states.

Farmer union leaders feel it is political fallout of freezing supplies to Delhi that will put the Centre on a sticky wicket and make them blink. "Our brothers from across the country are joining us in this fight. We will sit in protest at borders Tikri, Ghazipur, Narela and Faridabad border and intensify our stir, seal Delhi if the government doesn't roll back the farm laws. We have enough patience and courage," said Jagjit Singh Dallewala, who heads the coordination committee of the farmers union.

Farmers protest, signs of shortage seen in mandis

Signs of shortage are beginning to show with Azadpur Mandi, the largest wholesale fruit and vegetable market in Delhi, recording more than 50 per cent low supplies on Monday.

Delhi sees more polluted air in November this year than 2019

New Delhi Delhi witnessed more polluted air in November this year than in 2019, largely due to lesser precipitation and large-scale stubble burning. The national capital also recorded nine "severe" air days this November, the maximum number in the month in four years. There were seven such days in the month last year. Besides, there were five "severe" air days each in November 2018 and 2017, news agency PTI cited Central Pollution Control Board (CPCB) data. The 30-day average AQI in November stood at 328, in the very poor category, while it was 312 in the month last year, according to the CPCB data. An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500 "severe". According to PTI, the 30-day average was the lowest last year, while it was the highest (374) in November 2016. It was 335 in 2018 and 361 in 2017. Pollutions levels breached the emergency threshold twice this month as a grey apocalyptic smog enveloped Delhi for days, blotting out the sun from the sky and smudging landmarks from view

According to the Graded Response Action Plan (GRAP), the air quality is considered in the "severe plus" or "emergency" category if PM2.5 and PM10 levels persist above 300 µg/m3 and 500 µg/m3 for more than 48 hours. Pollution levels on Diwali this year and the day after were the maximum in the last four years despite the city government and the National Green Tribunal banning the sale and use of all kinds of firecrackers till November 30. The air quality started deteriorating in Delhi-NCR as people defied the ban on bursting firecrackers. Just a day after Diwali, a thick layer of haze was seen across the national capital and surrounding regions as emissions from firecrackers worsened the air quality, which has already deteriorated due to increased stubble burning activities. Kuldeep Srivastava, the head of the regional forecasting centre of the India Meteorological Department was quoted as saying that the air was fouler this November as there was lesser precipitation as compared to last year. "The monsoon withdrew around October 10 last year, while the wind system receded early this

year, around September 23-24," he said. Srivastava said that the city received rains only on one day this November. The number of rainy days was two nd three in 2019 and 2018, respectively. The other major reason was large-scale stubble burning, he said. Farmers started burning crop residue early due to early harvesting this year. Also, the farm fires raged for a longer duration. Punjab alone recorded 76,590 cases of stubble burning this season, the highest in the last four years. The number was 55,210 last year. An official from Indian Agricultural Research Institute (IARI) said that the incidents of stubble burning hit the peak between November 4 and November 7. According to the Ministry of Earth Sciences' air quality monitor, SAFAR, the share of stubble burning in Delhi-NCR's pollution peaked to 42 per cent on November 5, when 4,135 farm fires were recorded in the region. "It was a bumper harvest this year, so the amount of crop residue was also large. Also, it was a cloud-free season this year as compared to last year. The biomass was drier and prone to burning," the IARI official said.
